Requested to be put on Hardin Water Department Agenda dated January 14th, 2022, to ask about bore.

- G. Discuss and take action: Citizen sewer issues.
 - 1. Mr. Ziriax CR 2005 is having issues with the sewer line. Requested IUO to camera test and jet line.


