  - E. Discuss and take action: Mr. Scott Mackey, Superintendent for Hardin ISD would like to discuss the new safety measures in place for the 2022-2023 School Year. He would also like to discuss the need for officers to be at the elementary and junior high campuses in the mornings during drop off due to the number of people passing on the shoulder and not obeying traffic laws.
